Local Conservation Continues 50+ Year Partnership

Sawmill Brook Conservation Project, West Newbury 32 ACRES OF WOODLANDS, WETLANDS AND TRAILS

Greenbelt and the Town of West Newbury work to protect an important extension to the well-loved Mill Pond & Pipestave Hill Conservation & Recreation Area

At West Newbury's Town Meeting in April, a sea of hands rose waving their green "Yea" cards. Residents voted overwhelmingly to allocate municipal funds to support the Sawmill Brook Conservation Project. Town Meeting is often the moment of truth, when community members decide with their vote if a conservation project that Greenbelt and municipal partners have worked on for months is worthy of pursuing.

This successful Town Meeting vote wasn't simply the result of weeks of municipal meetings and a concerted get-out-the-vote effort by Greenbelt and the Open Space Committee. Those all helped, of course. But this vote reflected the confidence and trust that Greenbelt and the West Newbury community have been building since 1968, when they began partnering to conserve open space.

Over the past five decades, Greenbelt has helped to protect 840 acres in West Newbury. While Greenbelt may be the conservation catalyst, none of this would be possible without effective town management and leadership, and a robust and engaged Open Space Committee.

Also essential is the Community Preservation Act (CPA), adopted by West Newbury to provide a consistent source of municipal funding for conservation projects, pending community approval on a case-by-case basis. Now, with the Town of West Newbury's vote in April to support the Sawmill Brook Conservation Project with up to \$350,000 in CPA funds, Greenbelt is actively fundraising for the remaining amount needed to complete the project.

If successful, the Sawmill Brook Conservation Project will add 32 protected acres to West Newbury's Pipestave Hill & Mill Pond Conservation Area, expanding existing trails, protecting important habitat and clean water, and increasing the Town's resilience to the adverse impacts of climate change.


Haynes Elmlea Property Conserved! 42 ACRES OF WOODS, WETLANDS, HABITAT & TRAILS BOXFORD

This June, Greenbelt purchased the 42-acre Haynes Elmlea property in Boxford. This property was identified as a priority for protection by Greenbelt's 2019 Land Conservation Prioritization Analysis for its rare species habitat, and its ability to preserve biodiversity and store large volumes of flood water as our climate changes. Greenbelt is grateful for the generous support received from individuals, foundations and BTA/BOLT, and for the Conservation Partnership Grant awarded by the MA Executive Office of Energy and Environmental Affairs.

- Preserve critical wildlife habitat and connectivity for flora and fauna
- Ensure existing recreational trails remain uninterrupted and open to the public
- Strengthen climate resilience as it relates to biodiversity and flood mitigation
- Expand an area of existing protected land adjacent to the Town Common

Project Area

Crystal Lake Watershed Conservation

72 ACRES CRITICAL FOR WATER SUPPLY PROTECTION HAVERHILL

In partnership with the City of Haverhill, Greenbelt has permanently protected two parcels of land that encompass 72 critical acres of the Crystal Lake Watershed. Greenbelt acquired 19 acres and co-purchased the development rights on 53 acres with the City of Haverhill through a Conservation Restriction. Conserving this land protects it from development – preserving important wildlife, creating the potential to expand trails from Crystal Gorge Conservation Area, and helping safeguard the City of Haverhill's drinking water supply. Generous support was provided by individuals, foundations, and Conservation Partnership and Drinking Water Supply Protection Grants awarded by the MA Executive Office of Energy and Environmental Affairs.

- Eliminate the risk of development
- · Protect Haverhill's drinking water
- · Preserve threatened wildlife
- Expand Crystal Gorge Conservation Area
- Enhance Haverhill's public trail system

Project Area

Our Farms, Our Future

After a long agricultural history, our region is losing farmland at one of the highest rates in the nation. Within Essex County, over 14,000 acres of agricultural lands are currently unprotected and at risk of being sold for development.

Greenbelt has conserved more than 50 farms, protecting over 1,000 acres of working farmland in the county. While Greenbelt's work to conserve agricultural land is critically important to ensuring that farming remains a viable part of Essex County, there are other obstacles to address, such as finding affordable farmland – one of the greatest barriers facing new farmers today.



In addition to protecting farmland, Greenbelt's Farmland program:

- · Offers free farm-related educational opportunities with partner organizations
- Educates community members on benefits and impact of supporting local farms
- Works with farmers to create secure and affordable access to farmland

Through programs such as 99-year inheritable ground leases, farmer-to-farmer land transfers, and facilitation of Agricultural Preservation Restrictions, Greenbelt provides farmers with long-term stability and the opportunity to confidently invest in their farm and their future.


JEANNETTE MIRANDA GIS Intern

Growing with Greenbelt – Community Gardens SUPPORTING LOCAL FOOD PRODUCTION

Locally-grown food is healthy food. Greenbelt supports local food production not only through farmland conservation, but also by owning and managing two community gardens.

Young Farm Community Garden was established in 1995 in Lanesville Village, Gloucester. With 42 garden plots that are primarily "direct soil" planting beds, Young Farm is already well into the 2023 growing season!

Dodge Farm Community Garden, next to Pingree Park in Wenham, was founded in 2012 by a volunteer group of gardeners working with the Hamilton Wenham Open Land Trust (HWOLT). In 2022, HWOLT conveyed the land to Greenbelt, including 60 raised-bed garden plots. Please contact Greenbelt if you're interested in gardening one of these beds!

Lynnfield Woodlot

A plan for a six-vehicle parking area at the Lynnfield Woodlot is being reviewed by the Lynnfield Planning Board. Site work, construction, and trail work is scheduled to begin when permits and approvals are finalized. This work is part of a larger multiyear effort to activate and improve the trail system in the adjacent Willis Woods.



Soaring into Summer – Osprey Program's 14th Season

Another Osprey nesting season is well underway! Since the first sightings in March, Greenbelt's 30+ community scientist nest monitors have reported Osprey pairs on nearly all of the nests observed in 2022, plus additional nesting sites. In Essex County, Osprey are heavily reliant on human-made structures; over 80% of active nests are on wooden platforms like those installed by Greenbelt. Since the start of the Osprey Program, Greenbelt has installed more than 60 nesting platforms throughout the region, seven of which are new this season in Essex, Ipswich and Salisbury.

To observe an Osprey pair raising their brood up close, Greenbelt's OspreyCam live-streams the nest at Lobstaland Restaurant in Gloucester, where local favorites Annie and Squam are raising their three chicks: Atty, Babson and Lane. As the summer progresses, we'll continue to monitor all of this season's active nests. We're grateful to our many dedicated Osprey Monitors who submit well over 1,000 online reports each season, and who play a critical role in the success of Greenbelt's Osprey Program.

Monitoring Protected Land – Key to Good Stewardship CONSERVATION VALUES PROTECTED FOREVER

A critical tool in land conservation, a Conservation Restriction (CR) allows landowners to protect their property's future, ensuring it will be conserved forever. Greenbelt can serve as the legal "holder" of a CR, giving us the right and the responsibility to ensure the CR is not violated, even if the property is sold. Monitoring Greenbelt CRs on private and public property is a significant responsibility of Greenbelt's Stewardship team, working in close partnership with landowners to ensure long-term protection through the framework and management of CRs. Currently, Greenbelt holds 257 Conservation Restrictions totaling 8,000+/- acres.

The Stewardship staff completes 160-180 CR monitoring visits annually, representing 4,000-5,000 acres of permanently protected land.

At our annual Birds, Bees and Butterflies event in May, more than 100 people of all ages visited Cox Reservation to learn all about pollinators with hands-on activities and presentations by local beekeepers, native plant gardeners, and environmental educators.

Greenbelt is also working with SeniorCare Inc. of Gloucester to lead guided walks and meditation experiences for dementia patients and their caregivers. Offered by trained professionals where there are gentle trails and lovely resting places, these walks are refreshing and restorative.

While Greenbelt serves the 34 cities and towns throughout the county, some areas are more familiar with our work than others.
