

## GREENBELT SURPASSES HISTORIC **CONSERVATION MILESTONE**

As a non-profit organization tasked with the permanent protection of critical landscapes, wildlife habitat, and farmland in Essex County, Greenbelt's work is often measured in decades. We develop relationships with landowners over years, expand our partnerships with towns and state organizations, connect with foundations and individual supporters, all with the goal of being ready to act when conservation opportunities arise.

Founded in 1961, the Greenbelt of the past may have looked a bit different than our current organization, but the core mission has remained the same. Some of the first projects completed by Greenbelt's visionary founders during its formative years helped protect such beloved properties as Bald Hill and Willowdale Mill. By 1992, Greenbelt had conserved its first 5,000 acres and from there, the pace continued to accelerate.

With a growing staff of conservation experts and a groundswell of supporters and donors, Greenbelt has kept pace with conserving close to 5,000 acres per decade, surpassing the 20,000-acre milestone in 2023 with the permanent protection of the nearly 2,100-acre Lynn Woods.

We all recognize how important this conservation work is, from protecting recreational space for all to enjoy and safeguarding local agriculture to bolstering our region's climate resiliency. In the face of increasing pressure to develop property

across Essex County, Greenbelt's ability to maintain and expand its conserved acreage year-over-year is buoyed by a strong, growing base of support — from our community, our donors, and our conservation partners.

While our origins may have been modest, the Greenbelt mission remains increasingly vital. With more than 21,500 acres of land conserved to date, we are actively engaged in new projects that will continue to expand our impact and help propel us into the future.

### LYNN WOODS CONSERVED FOREVER!

A decades-long initiative by Greenbelt and multiple partners to protect Lynn Woods was completed in December ensuring that this vital community resource is now permanently protected from development.

Founded in 1881, Lynn Woods was one of the first – and for a time the largest – municipal parks in the country. Covering nearly 2,100 acres, the property encompasses many diverse ecosystems that include woodlands, wetlands, and ponds, providing important habitat for a variety of rare and endangered species. Additionally, the park boasts a number of historical landmarks that reflect the area's industrial past, as well as three drinking water reservoirs.

Over the years, Lynn Woods has faced many threats of development with proposals including a golf course and the rerouting of Route 95. Today, thanks to the perseverance of Greenbelt, working in close collaboration with the City of Lynn, the Friends of Lynn Woods, and the Massachusetts Department of Conservation and Recreation, this essential urban park is now permanently protected for future generations to enjoy.


# GREENBELT THROUGH THE YEARS
